



## Summer 2017 Financial Aid Information

Generally, students who have applied/received financial assistance during the Fall 2016 and/or Spring 2017 and who continue to meet Financial Aid Satisfactory Academic Progress may be considered as follows:

**Federal Pell Grant:** Available to qualified students who did not utilize their full Pell Grant eligibility during the academic year (Fall/Spring 2016-17). For example: If you received a Pell Grant for full-time enrollment both Fall and Spring you are NOT eligible for a Summer Pell. But, if you received a Pell Grant at half-time enrollment during the Fall and three-quarter-time enrollment in the Spring you may have Pell Grant eligibility remaining.

*Note: Any Federal Pell Grant received will be used toward your Federal Pell Grant Lifetime Eligibility. Monitor your Federal Pell Grant Lifetime usage at [www.nsls.ed.gov](http://www.nsls.ed.gov).*

**Federal Direct Stafford Loans:** You must be enrolled at least 6 credits at KCC during the summer. If you drop below half-time your financial aid may be cancelled and you will be required to repay all your aid. You are restricted to the annual limit for the academic year which includes any Fall 2016 – Spring 2017 borrowing. The annual limits are as follows:

	Base Subsidized & Unsubsidized	Additional Unsubsidized	Maximum Combined
<b>Dependent Freshmen:</b> (0 – 29 credits 100+ level)	\$ 3,500	\$ 2,000	\$ 5,500
<b>Dependent Sophomore:</b> (30+ credits 100+ level )	\$ 4,500	\$ 2,000	\$ 6,500
<b>Independent Freshmen :</b> (0 – 29 credits 100+ level)	\$ 3,500	\$ 6,000	\$ 9,500
<b>Independent Sophomore:</b> (30+ credits 100+ level )	\$ 4,500	\$ 6,000	\$10,500

*Note: Any Federal Direct Stafford loan will be used toward your Time Limitation on Direct Subsidized Eligibility and Aggregate Loan Borrowing. Monitor your borrowing at [www.nsls.ed.gov](http://www.nsls.ed.gov).*

### What Else Should I Know?

- Summer awards will be based on expected costs for the period of enrollment, enrollment level, and remaining eligibility. **Any changes to your registration may affect and delay your financial aid.**
- Prior to disbursement, eligibility will be determined. If your award is based on enrollment in both summer sessions aid may not be disbursed until 2<sup>nd</sup> summer session starts.
  - Example: *If financial aid is based on 6 credits and you are enrolled 3 credits summer session 1 and 3 credits summer session 2 we may not be able to disburse aid until you actually start attendance in the second session. This is true for student loans and may be true for Pell.*
- Financial aid will be applied to your KCC student account **no earlier** than:

Summer Session 1 (6 cr enrollment)	Summer Session 2 (6 cr enrollment)	Summer Session 1 and 2 (3 cr SS1 + 3 cr SS2 enrollment)
No earlier than: May 22, 2017	No earlier than: July 3, 2017	No earlier than: July 3, 2017
