### UNIVERSITY OF HAWAI'I MEMORANDUM OF AGREEMENT

# University of Hawai'i Community Colleges Associate of Science in Natural Science (AS-NS) with a Pre-Engineering Concentration to

## University of Hawai'i at Mānoa (UHM) Bachelor of Science in Engineering

#### Purpose & Goals

The purpose of this agreement is to facilitate the transfer of students who complete the Associate of Science in Natural Science (AS-NS) degree with a Pre-Engineering Concentration at participating University of Hawai'i Community College campuses to the University of Hawai'i at Mānoa (UHM) College of Engineering. This agreement is intended to streamline the transfer process, increase the number of students in the Engineering program pipeline, and ease the transition for transfer students to support timely degree completion.

#### Implementation

Students who successfully complete the AS-NS with a Pre-Engineering Concentration and a GPA of 2.0 or higher will be eligible for automatic admission into one of the Bachelor of Science (BS) degree programs in the UHM College of Engineering.

### Terms

- This agreement is effective for five years from the time of signing, and replaces all existing articulation agreements between UHM College of Engineering and individual campuses of the UH Community Colleges. The parties to this agreement will review the program one year prior to the expiration of the agreement to ascertain whether alterations are required.
- Campuses with newly developed AS-NS degrees with a Pre-Engineering Concentration must submit relevant documentation (program sheets, advising guides, etc.) to the UHM Vice Chancellor for Academic Affairs for review and approval before students can be recruited into the program. Current program sheets are available for access on the University of Hawai'i articulation website.
- Any new or proposed changes to the degree requirements in the AS-NS with a Pre-Engineering Concentration are to be communicated to the Dean of the UHM College of Engineering as soon as they occur.
- Any changes to the admission requirements to the UHM College of Engineering are to be communicated to the UHM Vice Chancellor of Academic Affairs whose office must notify the Vice Chancellors for Student Affairs at all UH Community Colleges of the changes in a timely manner.
- Changes made without agreement among the involved campuses may invalidate this agreement.
- Amendments to this agreement must be in writing and approved by designated representatives of each campus.
- Any party may terminate its participation in this agreement for cause by giving written notice to the designated representatives at least 90 days prior to the commencement of a new academic term.
- The terms of this agreement are subject to prevailing University of Hawai'i policies.
