Generally, students who have applied/received financial assistance during the Fall 2022 and/or Spring 2023 and who continue to meet Financial Aid Satisfactory Academic Progress may be considered as follows:

Federal Pell Grant: Available to qualified students who enroll at least half-time (6 or more credits) who may exceed their full-year scheduled award **OR** for students who enroll less than half-time (1-5 credits) and did not utilize their full year scheduled Pell Grant eligibility during the Fall and Spring semester.

*Example 1: If you received a Pell Grant for full-time enrollment both Fall and Spring you are **ONLY ELIGIBLE** for a Summer Pell if you enroll at least half-time (6 or more credits).*

Example 2: You received a Pell Grant at less than full-time enrollment during the Fall and/or Spring you may have Pell Grant eligibility remaining.

| 1/2x (6-8 cr) | Full-time (12 cr +) | 1 or more credits | YES |
| <1/2X (1-3 cr) | Full-time (12 cr +) | 1 or more credits | YES |
| 0 credits | Full-time (12 cr +) | 1 or more credits | YES |

Note: Any Federal Pell Grant received will be used toward your 600% Federal Pell Grant Lifetime Eligibility. Monitor your Federal Pell Grant Lifetime usage at <https://studentaid.gov>.

Federal Direct Loans: **You must be enrolled at least 6 credits at KCC during the summer.** *If you drop below half-time your financial aid may be cancelled and you will be required to repay all your aid.* You are restricted to the annual limit for the academic year which includes any Fall 2022 – Spring 2023 borrowing. The annual limits are as follows:

| Dependent Freshmen: (0 – 29 credits 100+ level) | \$ 3,500 | \$ 2,000 | \$ 5,500 |
| Dependent Sophomore: (30+ credits 100+ level) | \$ 4,500 | \$ 2,000 | \$ 6,500 |
| Independent Freshmen: (0 – 29 credits 100+ level) | \$ 3,500 | \$ 6,000 | \$ 9,500 |
| Independent Sophomore: (30+ credits 100+ level) | \$ 4,500 | \$ 6,000 | \$10,500 |

What MUST I Know (terms)?

- You must be registered by **June 13, 2023**, which is the Summer **Financial Aid Enrollment Status Date**.
- **Adjustments of awards (decreases/increases) will be made through and finalized after the Financial Aid Enrollment Status Date.** Any classes (that apply to your KCC degree) that are added or dropped **on or BEFORE** this date will impact your awards, even if aid was already disbursed/refunded to you. *Courses added/dropped after this date will not impact your awards*
- Summer awards will be based on expected costs for the period of enrollment, enrollment level, and remaining eligibility. **Any changes to your registration will affect and delay your financial aid.** Please inform the financial aid office of any changes to your registration.
- You **MUST** be enrolled in at least 1 KCC course.
- Under certain conditions you may be able to receive financial aid for courses you are concurrently enrolled at other University of Hawai'i campuses. The conditions are:
 - You **MUST** be enrolled in at least one course at KCC
 - The course(s) is applicable toward your degree program (refer to [Course Program of Study](#))
- You must meet [Financial Aid Satisfactory Academic Progress \(SAP\)](#) at the end of Spring 2023.
 - Minimum Cumulative KCC Financial Aid GPA of at least 2.0.
 - Credit completion rate of at least 67%
 - Financial Aid time frame of 150%
- Prior to disbursement, eligibility will be determined. If your award is based on enrollment in both summer sessions aid may not be disbursed until 2nd summer session starts.
 - Example: *If financial aid is based on 6 credits and you are enrolled 3 credits summer session 1 and 3 credits summer session 2 your aid may not be disbursed until you actually start attendance in the second session, provided you are still enrolled in 6 credits.*
- Financial aid will be applied to your KCC student account **no earlier** than:

- Any Federal Pell Grant awarded will be used toward your Federal Pell Grant Lifetime Eligibility (you have a lifetime eligibility of 600%). Any Federal Direct Loan will be used toward your Aggregate Loan Borrowing limit. Monitor your Federal Pell Grant Lifetime usage & Federal Direct Loan balances at <https://studentaid.gov>.
