Subject: Title IX and Mandatory Reporting

Thank you so much for trusting Kapi'olani Community College (KapCC) with enrolling your child in our Dual Credit program. This is a great opportunity for high school students to earn college credits before they receive their high school diploma.

As Dual Credit students of KapCC, they have full access to the resources we offer. I want to bring attention to KapCC's Title IX and mandatory reporting that states,

"Kapi'olani Community College is committed to maintaining and promoting safe, respectful campus environments that are free from discrimination, harassment, and sexual violence. The University prohibits and does not tolerate sexual harassment, sexual assault, domestic violence, dating violence, and stalking. These forms of sex discrimination and sexual misconduct are prohibited by law and are serious offenses that violate the basic standards of behavior expected of members of the Kapi'olani CC community. Such conduct substantially interferes with a person's civil rights to equal opportunity in employment, education, and/or access to Kapi'olani CC programs, activities and services, whether on or off-campus. The College will take appropriate action to prevent sexual harassment, sexual assault, domestic violence, dating violence, and stalking."
